Sub : Filling up Examination Forms and submission of Alphabetical List, Accounts Statement in support of Examination Fees, Bank Draft along with other related documents for Enrolment of students for the MA/M.Sc./ M.Com – 2nd Sem. (Regular) Examination, 2020 (2019 Admission Batch) .

Madam/Sir,

You are requested to take necessary steps for filling up Examination Forms of the eligible students admitted in different subjects under MA/ M.Sc./M.Com. course during the Academic Session (2019-20 Admission Batch) in PG Departments, Rama Devi Women's University and Kamala Nehru Women's College, Bhubaneswar for the above Examinations.

N.B. : The students admitted in Kamala Nehru Women's College, Bhubaneswar during the Academic Session 2019-20 may fill up Forms for enrollment in MA/M.Sc./M.Com 2nd Semester (Regular) Examination,2020 in such subjects applicable for their students.

The subjects under MA/ M.Sc./M.Com Course are as follows:

(1) Economics, (2) Education, (3) English, (4) Gender Studies, (5) Hindi, (6) Home Science, (7) Political Science, (8) Odia, , (9) Sociology, (10) Biotechnology, (11) Computer Science, (12) Life Science, (13) Industrial Microbiology (14) Commerce.

- I. Eligibility of candidate to fill up Examination Form for MA/M.Sc./M.Com 2nd Semester (Regular) Examination, 2020.
 - (a) She must have been enrolled/Registered for the MA/M.SC./M.COM Ist Semester (CBCS) Regular Examination, 2019-20
 - (b) She must not have taken C.L.C.
 - (c) A student having 'F' grade in any paper can re-appear any number of times within the stipulated period of twice the duration course until she gets at least 'D' grade.

The candidate will retain her previous Examination Roll Number which was at Ist Semester University Examination simply by adding (B) at the end for Back Examination.

VI. Preparation of Alphabetical List

The Alphabetical List shall be prepared for (Regular) Examination containing Name of Candidate, Examination Roll Number, Registration Number, Paper Code to be examined. All entries in the Alphabetical List shall be made in Capital Letters and the names of the candidates shall be carefully typed without mistake. SC/ST/Disabled may be indicated against each name of the candidate positively.

VII. Deposit of Fees :

The fees so collected from the students except Centre charge shall be paid to the University in shape of consolidated Bank Draft of any Nationalized Bank **in favour of Comptroller of Finance, Rama Devi women's University, Bhubaneswar payable at Bhubaneswar. (EXCESS AMOUNT IF PAID BY THE COLLEGE/DEPTT. WILL NOT BE ADJUSTED OR REFUNDED).** Care should be taken to put up the College/Institution Seal, College/Institution Code and name of the Examination in the Back side of the Bank Draft.
