In partial modification to the Office order No. CoE/EC-27-288/2021 dated 24.03.2021 of the +3 Degree Arts/Science/ Commerce (Pass & Hons) 1st Semester Regular Examination, 2019 (2019 Adm. Batch) result notification, the matters regarding Re-Addition/Re-Checking at unevaluated portions and Photo Copy of Answer Scripts are hereby modified.

Re-addition of marks /Re-Checking at un-evaluated Portion/Photocopy of answer Scripts:

- A Student may apply through her college for Re-addition/Re-Checking of a paper within 15 calendar days from the date of publication of the results in each Semester. In case, there is any answer left unvalued the same will be placed before the Board of Conducting Examiners of the respective subjects for valuation. The Xerox copy of answer scripts and information regarding readdition of marks will be intimated to the candidate within 45 days.
- A candidate desiring for re-addition of marks/photo copy of answer scripts may apply for the same in the prescribed application form available in the college concerned depositing Rs.50/- (Rupees fifty) only for re-addition of marks per paper and Rs.300/- (Rupees three hundred) only for photo copies of answer scripts per paper within 15 days from the date of publication of the result.
- All the Principals of the college are to provide prescribed application form of the University to the students of their college downloading from the website of this University and receive the said application duly filled in by the candidate with the prescribed fee within 15 days from the date of publication of the result. After completion of 15 days from the date of publication of the result, a list of applicants specifying Sl.No./Roll No./Subject-Paper/Name of the valuation zone for re-addition/rechecking of marks or obtaining photo copies of answer scripts must be prepared valuation zone/College wise and the same list is to be sent to the Controller of Examinations along with the application fees received from the students as demand draft made in favour of the Comptroller of Finance, Rama Devi Women's University within five days from the last date of receiving such application.
