You are requested to take necessary steps to verify the students details (admitted during the year 2019-20) of Ist Year Arts/Sc./Com. (Pass & Hons) of College/Institution and update in the Form Fill up link in the College Login for the **5th Semester Examination** as per the regulation of the State Govt. letter dated 13.09.2019 which has already been circulated to your institution by Govt. of Odisha.

I. Eligibility criteria for Registration/Enrolment to the +3 5th Semester (CBCS) Regular University Examination,2021 (2019 Admission Batch)

The Registration/ Enrolment of eligible candidates to the +3 5th Semester (CBCS) Arts/Science/Commerce (Pass/Hons) Regular University Examination,2021 is compulsory.

- (a) She must have taken admission to the +3 Ist Year Degree course under (CBCS) pattern in Arts/Science/Commerce (Pass/Hons) during the Academic year 2019-20.
- (b) Any Registered students of the University may be admitted to the +3 Ist Semester (CBCS) Arts/Science/Commerce (Pass/Hons) Regular Examination,2019 in which she offers a regular (CBCS) course of study for not less than six months after passing the council of Higher Secondary Education, Odisha or any other equivalent Examination.

II. Mode of Form Fill up : ONLINE

The Examination Application Forms for +3 5th Semester (CBCS) Arts/ Science/ Commerce (Pass/Hons) Regular students shall be submitted through **ONLINE**. For Filling up Examination Forms ONLINE one has to log on to rdwuniversity.nic.in and then Click e-Examination button.

III.(a) Preparation of Alphabetical List of Regular Candidates

The Alphabetical List of Arts/Science/Commerce shall be prepared Pass/Hons. wise separately containing names of candidate, Roll no., Registration No and Subjects to be examined and care should be taken to indicate SC/ST/Disabled etc. against each of their names for students separately. Students details should be uploaded online from **04.01.2022 to 17.01.2022** in University website www.rdwuniversity.nic.in positively.


