**NOTIFICATION**

Consequent upon the Syndicate resolution no. XVII-S/Syndicate/Resolution/4839/29.09.2022 the following resolved items were notified herewith. It has to be followed from the date of notification.

1. The remuneration for Invigilation of "Ethics & Values" is Rs.30/- per invigilator as it is carrying 25marks and of 1 hour duration.
2. Remuneration for Evaluation of newly introduced "Ethics & Values" paper from 2021 Admission Batch is Rs.15/- per script with minimum remuneration of Rs.150/- (this is to be evaluated at college level). The bills with account details of the examiner in support of valuation of Ethics & values countersigned by the Principal/HoI shall be submitted in the Office of the Controller of Examinations within due time for payment.
3. The Travelling Allowance is @Rs.1/- per Kilometer for the personel travelling to the Univertsity through own vechile/public transport for different purposes(Examinatio/valuation/moderation/conducting board/board of studies etc).
4. The photocopy charges@ Rs.2/-(bothside) is included in the Re-additon of Valued Answer Scritps as a separate head.
5. The Re-addition amount of Rs.2000/-(per zone) is included in the Zone advance. The zones shall submit bills & vouchers in support of the valuation advance as per valuation guideline keeping the Re-addition amount of Rs.2000/- separate from the valuation advance after completion of the zone. The bills & vouchers in support of Readdition may be submitted including unspent balance of Re-addition soon after the completion of Readdition process.
