Madam/Sir,

You are requested to take necessary steps to verify the student's details (admitted during the year 2022-23) of Ist Year Arts/Sc./Com. (Pass & Hons) of College/Institution and update the same in the Form Fill up link in the College Login for the Ist Semester Examination.

I. Eligibility criteria for Registration/Enrolment to the +3 Ist Semester (CBCS) Regular University Examination,2022 (2022 Admission Batch)

The Registration/ Enrolment of eligible candidates to the +3 Ist Semester (CBCS) Arts/Science/Commerce (Pass/Hons) **Regular** University Examination,2022 is compulsory.

- (a) She must have taken admission to the +3 Ist Year Degree course under (CBCS) pattern in Arts/Science/Commerce (Pass/Hons) during the Academic year 2022-23.
- (b) Any Registered students of the University may be admitted to the +3 Ist Semester (CBCS) Arts/Science/Commerce (Pass/Hons) Regular Examination,2022 in which she has undergone a regular (CBCS) course of study for not less than six months after passing the council of Higher Secondary Education, Odisha or any other equivalent Examination.

II. Eligibility of students for Back Examination,2022

- (a) She must have taken admission in the First Year +3 Degree Course under (CBCS) pattern in Arts/Science/Commerce (Pass/Hons)during Academic Year 2021, 2020, 2019,2018 & 2017.
- (b) She must not have taken CLC.
- (c) **Back Paper appearance** : A student has to clear back paper(s) if failed by appearing at subsequent semester examinations within six years from the Year/Session of admission.
- (d) **Improvement** : The student may appear in improvement (having passed in that paper) in any number of papers only once in the next semester examination & there is no improvement in practical paper.
- (e) The candidates are required to produce their Mark Sheet (xerox copy) in case of Back paper appearance/ Improvement appearance for verification to appear the Ist Semester (Back) Examination,2022.
- (d) She must have taken admission in the First Year +3 Degree Course under (CBCS) pattern in Arts/Science/Commerce (Pass/Hons) during Academic Year 2017-18,2018-19,2019-20,2020-21 and 2021-22.
- (e) She must have been admitted/enrolled to the +3 Ist Semester (CBCS) Regular Examination, 2017-18,2018-19,2019-20,2020-21 and 2021-22.
- (f) She must not have taken CLC.
- (g) **Back Paper appearance** : A student has to clear Back paper(s) (i.e. the paper / paper(s) one has failed, having secured grade 'F' by appearing at subsequent semester examinations within six years from the Year/Session of admission.

If the candidate is Absent in any sitting(s) or Failed –("F" Grade), such a candidate shall have to reappear in that paper(s)/ Subjects in order to clear the back paper(s) at least 'D' Grade .

If a student of 2019 Adm. Batch is failed due to absent in Mid Sem. She will fill up the form for Back examination and appear the semester examination as per the schedule.

III. Preparation of Alphabetical List of Regular Candidates

The Alphabetical List of Arts/Science/Commerce shall be prepared Pass/Hons. wise separately containing name of candidate, roll no., Registration No and Subjects to be examined and care should be taken to indicate SC/ST/Disabled etc. against each of their names for students separately. **Students details for Form Fill up should be uploaded online on or before 24.02.2023** by clicking on www.rduems.in The link will remain open from 13.02.2023 to 24.02.2023.
